STUDENT EXCHANGE AGREEMENT

BETWEEN

Department of Computer Science and Information Engineering **National Taiwan Normal University**

Department of Information Technology Uppsala University

In accordance with the signed Memorandum of Understanding on November 9, 2015 between the Department of Computer Science and Information Engineering of the National Taiwan Normal University and the Department of Information Technology of Uppsala University, the exchange of students between the two institutions is agreed upon on November 9, 2015, under the following guidelines.

- 1. Each department shall take-in up to 3 senior or graduate level students per academic year from the partner department, to be enrolled according to the host University's requirements.
- 2. Each department shall aim for equal number of exchange students between the two institutions.
- 3. Each exchange student shall register as a full-time student at the home University and shall carry a full-time course load as governed by the host University. The host University will impose no additional tuition fee on the exchange students. (Other costs, including accommodation, international travel, books, supplies, meals, health insurance, and other incidental expenses arising out of the exchange, will be the responsibility of the exchange student. The host institution will seek to accommodate exchange students on campus wherever necessary. When possible, both institutions will attempt to provide financial assistance to exchange students.)
- 4. Each exchange student shall master English to such sufficient level to manage the studies at the host University.
- 5. Each exchange student is regarded as a full-time student at the host University and enjoys the same University privileges as the other full-time students.
- 6. Each department or university shall provide an official Transcript of Record and course grade information to the home institution at the end of each semester. Recognition of course credits for degree requirement is subject to the regulations of the home University.
- 7. Neither department shall be liable to the other or held to be in breach of this Student Exchange Agreement to the extent that it is prevented or delayed in performance or observance of its obligations by reason of most serious or unforeseen accidents, natural disasters or any other contingency whatsoever beyond its control. The two departments, however, are obliged to work together and try hard to avoid or reduce the damages or losses.
- 8. Disputes shall primarily be settled amicably. If no solution can be reached, they shall be finally settled under the Rules of Arbitration of the International Chamber of Commerce by one or more arbitrators appointed in accordance with the said Rules. The arbitration shall take place in Zurich.
- 9. This agreement will be effective from the fall semester of the 2016 academic year and is valid for five years.
